Insurance

The Town of Old Orchard Beach requires any organization holding an event in the Town to have a Comprehensive General Liability Policy insuring liability and property damage against all claims and demands for any personal injury to or death of any person and damage to or destruction or loss of property which may have or be claimed to have occurred at the Ballpark in an amount not less than \$1,000,000, single limit, for injury to or death of one person, \$2,000,000 for injury to or death of more than one person in any single accident, and for not less than \$300,000 for damage to or destruction or loss of property.

The Town shall be listed on the required insurance policies as an additional co-insured, and the insurer shall provide to the Town certification of the required insurance and that the Town is a co-insured. Nothing in this paragraph shall be deemed to waive any immunity available to the Town under any State or Federal law, including but without limitation the Maine Tort Claims Act, codified at 14 M.R.S.A. §§8101, et seq.

Indemnification of Town.

Event Cancellation

Cancellations can occur for many reasons. Because so many events are scheduled months ahead of time, there are times it may be difficult to accommodate rescheduling. The Ballpark, however, has held a time slot open that most likely will not have sufficient time to be rescheduled and the fees for that time slot are included as revenue in the Ballpark's budget. In these cases, fee refunds may not be possible if an event is canceled.

In the case of a client canceling an event due to a preventable condition, the fee will not be refunded. If the scheduled event cannot be held due to an unpreventable circumstance, every attempt shall be made to reschedule the event and a portion of the fee shall be considered for refund.

On occasions when a game or event must be canceled by the Ballpark due to weather or unforeseen circumstances, every attempt shall be made to reschedule the game or event. If rescheduling an event canceled due to a Ballpark decision is not possible, a refund shall be issued promptly.
